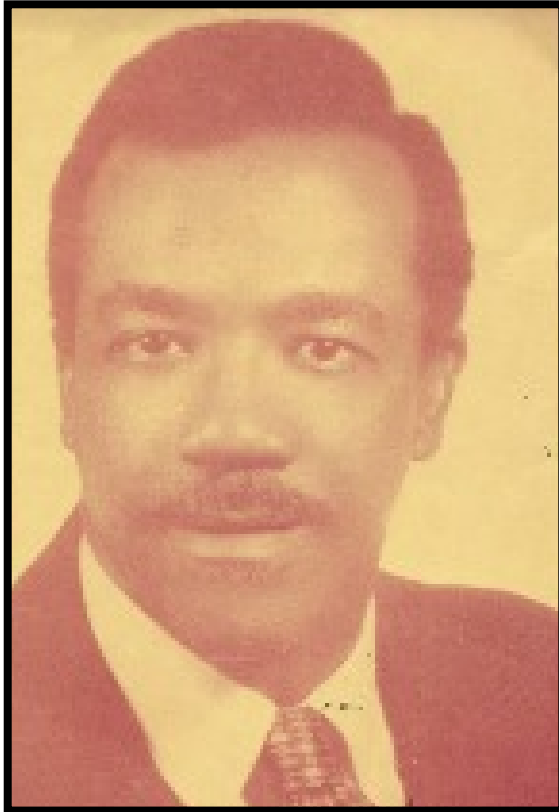

*Don't lengthen it now with undue grief.*

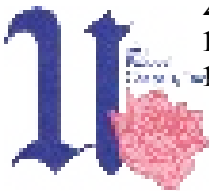
*Lift up your heart and share with me,*
