<u>Reflections of Life</u>

James Aubrey Stevens, Jr. affectionately known as "Bumpy" departed this life on November 21, 2013. Bumpy was born to the late James A. Stevens, Sr. and Dorothy M. Pollard Stevens on September 8, 1950. He was baptized at an early age and lived his life following the Golden Rule.

Bumpy was educated in the Jersey City School system. He attended Ferris High School where he was a member of the track team. He was a proud member of the 1968 Group III 2 mile Relay City Championship team, along with John Knight, Carlyle Stewart and Elijah White. He also set a county record for the 2-mile run and was declared County Champion in 1968. His record held up for at least twenty years.

Bumpy attended Jersey City State College (now NJCU) where he was an active member of the Iota Phi Theta fraternity, the cross-country track team, and lead dancer in the African Dance Group. He was also President of the Black Freedom Society where he was introduced to and had lunch with Bobby Seale when members of the Black Panthers visited the Campus.

Bumpy was employed by the United States Postal Service, retiring in 2005. While at the Post Office he worked as a letter carrier for thirteen years and supervisor of letter carriers and clerks for twenty years. Bumpy was proud of the fact that for twenty-one years of his thirty-three year career he never used any sick days.

Bumpy was known throughout the community for his athletic contributions. He was the Aerobics instructor for the Teen Post and he coached the Jersey City Recreation Bergen-Lafayette Volleyball team to a championship in 1985. He was also passionate about baseball. Starting in 1992, he umpired little league, high school, and Hudson County CYO baseball games and girls' softball games. He also officiated junior varsity basketball games. Bumpy coached the St. Peter's Prep freshman outdoor track team to the Jersey City city championship in 1981. He was also afforded the opportunity to umpire at the new Yankee Stadium in 2011. As an avid St. Anthony Friars and NJCU basketball fan, for years he rarely missed any games whether home or away. "Bump" was the quintessential 'people person'. With his gift of gab and engaging personality, he made a lasting impression on anyone he met. He loved to dance and during the 'disco' era he could be found at The Dome and The Cheetah in Greenwich Village every weekend. (Even at age 63, he enthralled the audience with his famous split when called to the stage at a Las Vegas show in August of this year.) He later became a popular DJ for parties and events throughout Jersey City. He enjoyed playing on the 1987 Morlees championship baseball team with many of his longtime friends. Bump enjoyed photography and photographed several weddings in and around the city.

He leaves to cherish his memory his loving wife, Linda. After their 'love-at-first-sight' meeting, they spent thirty-six years enjoying life together. Travel was their favorite pastime and Bump was the couples 'travel agent'.

He was predeceased by his father, James Sr. He is also survived by his mother, Dorothy; six sisters, Phyllis of Stone Mountain, GA, Geneva of Willingboro, NJ, Elizabeth of Willingboro, NJ, Patricia of Belleville, NJ, Catherine of Lithonia, GA and Beatrice (Gregory) of Willingboro, NJ; one brother, Robert of Stone Mountain, GA; and a host of aunts, uncles, nephews, nieces, other relatives and friends.
