

This is my personal obituary, written by me in the month of December 1, 2004, 12:15PM. On June 5, 2015 **Deacon Thomas Crawley, Jr.**, was called to rest, to possess the "New Life Eternal" that has been promised to all of God's saints who put their trust in JESUS CHRIST as their personal savior. God called him from labor to rewards.

Thomas was born in Emporia, Virginia on August 5, 1942 to the late Elder Thomas Crawley, Sr. and Missionary Romaine G. Crawley. He grew up in St. Paul Church of God in Christ under Pastor R. N. Johnson, with Missionary Eva Jackson and her husband Deacon Russell Jackson as youth leader. He received Jesus Christ as his personal savior during a Tent Revival meeting called "The Herald of His Coming" in 1955. He attended elementary school at R.R. Moton; the Edward W. Wyatt High School from which he graduated in 1962. He moved to Newark, NJ that same year, where he joined Morning Star Church of God In Christ under the leadership of Elder Willis. In 1978, he joined The House of Prayer Church of God in Christ where Elder Calvin Croslin was pastor. After he passed, Elder Clarence C. Williams became his pastor, who appointed him to be a deacon and Sunday School teacher for the adult class after the passing of Deacon Moses McWhorter. He enjoyed decades of teaching until January 2015. He sang in the choir, served as a trustee, worked in the Mercy Food Pantry with then Missionary Frances Baker. He also went to the Nursing Home with Missionary Baker and Missionary Cora Barr ministering to the patients there for a while.

Deacon Crawley was introduced to Sis. Renee M. Bingham by Mother Thelma McWhorter in 1981 at the 1<sup>st</sup> Jurisdiction Spring Conference in Trenton, NJ. They were married June 26<sup>th</sup> 1982 by Pastor Clarence Williams, and her grandfather Elder Andrew Hicks, Assistant Pastor, of Holy Trinity Church of God in Christ. Their union was a blessing from God as they continued to grow together in love; they enjoyed four godchildren.

Thomas and Renee loved to go on cruises or fly to exotic places. He was devoted to Sis. Renee, whom he always called "SWEETIE". He worked for sixteen years for Highlander Sportswear Leathers; eight years for NJ Rehabilitation/Kessler Institute; eleven years for National Starch and Chemical Corp. and, four years for Hoffman LaRoche Pharmaceutical. He retired in August 2004 and enjoyed life puttering around outdoors and carpentry inside.

Pre-deceased by his father, Thomas Jr. leaves his *Devoted* wife, Renee of almost 33 years; his mother, Romaine of Virginia; 4 sisters: Mary Mattox of Maryland; Frances Boyd of Maryland; Blanch (Myron) Alston of Maryland; Joyce Kelley, NJ; 6 brothers: James (Dora) Crawley of NJ; Edward (Chiffon) Crawley of North Carolina; Russell (Diane) Crawley, NJ; William (Sandra) Crawley of NJ; Louis (Willie Mae) Crawley of Maryland; Ronald (Roxann) Crawley of NJ; one adopted sister, Priscilla Atkinson of Washington, DC; Mother-in-law, Mrs. Marguerite Bingham, NJ; sister-in-law, Sylvia (Stephen) Gibson, NJ; 2 brothers-in-law: David (Earlene) Bingham and Glen (Loretha) Bingham; 4 godchildren: Kadijah Freeman, Darius Cook, Andrew Taylor and David Woody; as well as a host of nieces, and nephews, saints and friends.
