Evangelist Carol's Life and Legacy

Carol A. Richardson Frazier-Smith was born in Elizabeth, New Jersey on June 6, 1944 to the late Anna Wallace Richardson and James Richardson. She attended Elizabeth Public School system and graduated from Battin High School in 1962.

Her Christian experience began at an early age at Union Baptist Church in Elizabeth, New Jersey. She was filled with the Holy Ghost and received a deeper life in Christ through the ministry of Rev. Mother Redding of Newark. Carol served as a Missionary-Evangelist under Pastor Daisy Lawson at Faith and Victory Church in Elizabeth. In 1985, she became an active member of Bibleway Deliverance Center Church under the leadership of Bishop Wayne L. Johnson where she was a licensed Evangelist, member of the Mother's Board, Deaconess Board, Missionary Board, Pastor's Aide, Radio Guild, and Kitchen Committee. She had great culinary skills and was an accomplished cook and baker, known for her lemon and red velvet cakes specialty. She could always be found in the kitchen at home or at church catering and preparing gourmet tastings for all occasions.

Evangelist Frazier-Smith was a front row worshipper and praiser and was not ashamed to make a joyful noise unto the Lord in every service. Her favorite saying was "God is Good." She loved God, her family, church, and pastor. She was a tither and stalwart supporter of the church's vision and mission. It was her desire to tithe a million dollars into the ministry. In 2006, she wrote a check by faith for a million dollars to the church which remains in the back of her checkbook. As a final act of love and support to Bibleway Deliverance Center, she personally wrote out a check from her hospital bed for her first Sunday tithes and had it delivered directly to the Pastor.

Evangelist Frazier-Smith was previously employed by Margareta Mortgage Company in Woodbridge, New Jersey as a Foreclosure Analyst, before retirement. She was also employed as a Cook for the Morning Star Day Care in Linden, New Jersey for five years. In 2012, she was united in holy matrimony to her childhood friend, Deacon John Smith. Together they spearheaded the Bibleway-Path Mark "free bread" program and were known throughout the community for rescuing the perishing and caring for the unfortunate.

Evangelist Frazier-Smith was a devout soldier in the army of the Lord. The last words she uttered to her daughter over the telephone was, "Honey, God is Good, no matter what...ok (it is well)."

Evangelist Carol Frazier-Smith was called home to be with the Lord on Monday morning, October 5, 2015 at Trinitas Hospital in Elizabeth, New Jersey.

She leaves to cherish fond memories, her husband, Deacon John Smith; son, Michael Wall (Sheila) of Atlanta, GA; daughter, Roberta Denise Randle (Andre) of Raleigh, NC; brother, James Richardson and sister, Nettie Jordan (Clifford, Sr.) both of Elizabeth, NJ; two granddaughters, Jasmine and Kendra Randle; step-daughter, Deborah Smith; four nieces: Barbara Tate (Jerome), Victoria Goyins, Linda Richardson and Audrey Roney; three nephews, Kevin Mingo (Lisa), John Richardson, and Clifford Jordan, Jr.; and a host of other relatives and friends.
