Obituary

Granger W. Searvance Sr, was born on April 12, 1930 to Vera (Davis) and Aby Servance Sr. in Winston Salem, NC and relocated to Jersey City at the age of 3 months. He departed this life on January 2, 2016 in the quietness of his home. Granger was the oldest of six children. He grew up in the downtown area of Jersey City and Booker T. Washington Housing Development. Granger was educated in the Jersey City school system, attending Public School #3 and graduating from Lincoln High School. He earned an Associates Degree in Accounting.

Granger began his Christian life at an early age and became a devoted member of the Christ the King Catholic Church in Jersey City. He was a member attending faithfully until his recent illness. He continued to receive Holy Communion at home.

While in high school Granger was a gymnast. He was a member of the Jersey City Department of Recreation Gymnastic team, which won the Metropolitan Junior AAU championship. His team performed at West Point and Madison Square Garden. In 1963 Granger made a bid for the U.S. Olympic team.

After high school he enlisted in the United State Army where he served 4 years 3

months. He was injured by a rocket attack while in Korea and returned to the States where he received a warm hero's welcome. Granger was awarded the Purple Heart. He continued to serve in the States until receiving an honorary discharge. In 2000 Granger was recognized as a recipient of the Distinguished Service Medal, New Jersey's highest military commendation for courage and patriotism from the New Jersey House of Representatives.

In 1952, he married Betty Jean Solomon, and from this union came five children Kenneth, Lynn, Granger Jr., Gregory and Rozlyn. Later he remarried Lorraine (Brown-Stephens) and was the step-father to Robert, Michael, and William.

Granger worked at Emerson Electronics, Gray-Stone, ASPCA, and the United States Postal Service as a mail carrier until his retirement. He taught gymnastics at Y.M.C.A, Lincoln High School and St. Peter's Preparatory School.

Granger was an avid bowler and a member of numerous bowling leagues. He was a fine visual artist and an excellent dancer. Granger was a skilled barber and routinely cut his children's hair as well as the neighborhood kids.

Granger had many nicknames, "Brother" from his older relatives; "Killer" for his bowling prowess; "D.A" (District Attorney) was given to him by his children because of his strict discipline.

Granger was preceded in death by his children Lynn and Granger Jr., brothers Aby Jr.,

Raymond, Frederick (Freddy), sister Barbara Jean, parents Vera and Aby Sr. Granger is survived by his spouse Lorraine, his children Kenneth, Gregory, Dr. Rozlyn Searvance and step-children Robert, Michael, William and brother Theodore (Teddy); 4 sisters-in-law, 4 brothers-in-law, and 1 daughter-in-law; 17 grandchildren and 17 great grandchildren and a host of relatives and friends. He also leaves behind his beloved cat and companion Simba who would spend many hours at his bedside.
