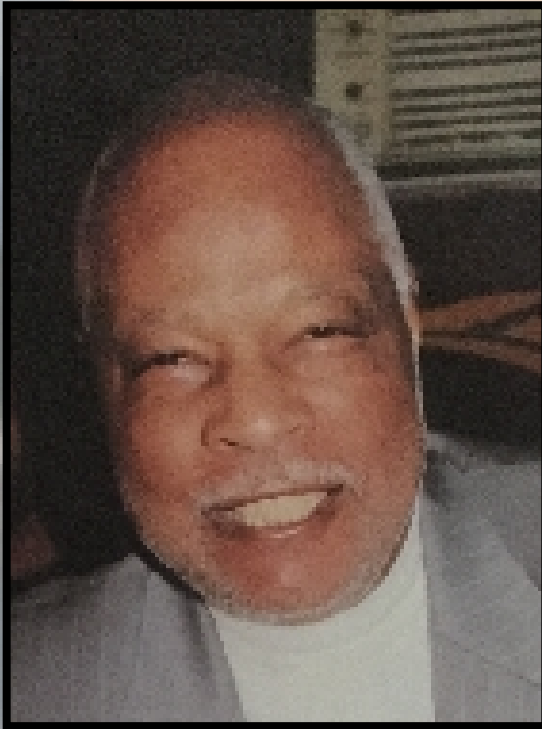

Obituary

Paul Dietrich, was born on August 4, 1944 in East Orange, New Jersey to the late Idel Carthan and Abraham Dietrich. Paul departed this life on Saturday, June 25, 2016 in Edison, New Jersey.

Paul was educated in the Newark School system, graduating from Weequahic High School and furthered his education at the Essex County College and Rutgers University.

Paul was Honorably discharged from the United States Marine Corps with the Third Recognizance Battalion, First Combat Troops in Vietnam. He has worked with the Newark Police Department (Records Clerk), Frank Briscoe Construction Company (Field Accountant), Essex County Jail (Corrections Officer), United States Department of Justice (Deputy U.S. Marshal, Inspector, Senior Criminal Investigator), Housing Authority of the City of Newark (Chief of Security) and Columbus Hospital (Security).

During his career Paul was Equal Employment Opportunities Manager for the U.S. Department of Justice, U.S. Marshals Service. Developed written E.E.O. program for the training of high school students. Represented the U.S. Marshals Services at local colleges, schools, and community organizations. Representative for the U.S. Department of Justice for the 1983 and 1984 Presidential National convention for the Handicapped. Treasurer/Trustee of Pilgrim Baptist Church, Member of Batons Inc., National Black Police Association, National Organization of Black Law Enforcement, and the International Council of Deputy U.S. Marshals.
