*D*orothy “Dot” Curry passed away peacefully at her

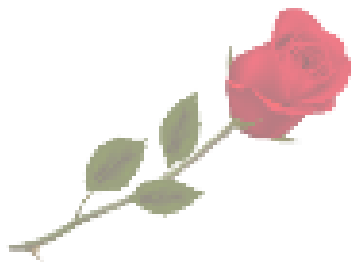
