# *Obituary*

**Marva Delores Moore** Was The Second Child Of Theophilus And Clarissa Edwards Of Boscobel, St. Peter In Barbados And Was Born On July 14, 1941.

After Receiving Her Formal Education In Barbados, Marva Worked As A Nurse For A Short Period Before Heading Up North To New York During The Mid Sixties. When Marva Migrated To The United States She Joined And Resided With Her Older Sister Celeste, In The Borough Of Brooklyn.

Marva Met Her Late Husband Rudolph Moore, Sr., At The Local Post Office On Empire Blvd In Brooklyn. They Soon Developed A Relationship And Were Married On May 10, 1968. Her Marriage Produced Two Beautiful Children, Rudolph Jr. And Fay.

In June Of 1968 Her Career As A Professional Nurse Started When She Began Working At Wyckoff Heights Medical Center In Brooklyn. Marva Was Assigned To The 5-south Intensive Care/dialysis Unit From Which She Retired In 2003. Marva Spent 35 Years Of Dedicated Service To The Nursing Profession.

Marva's Religious Values Were Shaped And Developed At An Early Age Growing Up In Boscobel, St. Peter, In Barbados. She Attended Church Every Sunday, Attending Morning Service, Sunday School And Night Service At St. Phillips The Less Church In Boscobel, St. Peter In Barbados. Marva Was Always A Devout Christian And Continued This Tradition In 1986 When She Was Invited To Attend A Revival By Her Friend Irma Benn At Triumphant Apostolic Church Of Jesus Christ, Inc. Marva Then Re-dedicated Her Life From That Day Forward To Jesus And Was Reminded That Jesus Was The Way, The Truth And The Light.

In 2001, Marva Decided To Join St. James Holiness Church To Worship With Her Daughter And Grandchildren. She Was Lovingly Called "Mother Moore" By Her Church Family, She Helped In The Food Pantry Where She Would Assist With The Preparation Of Food Packages For Those In Need, And Participated In Many Of The Church Activities. She Was A Faithful Servant, Loyal To The Congregation And To The Pastor And Remained A Faithful Member Of St. James Holiness Church To The Very End.

Marva Departed This Life In Peace On Saturday, March 25, 2017. Marva Is Survived By: Her Beloved Son, Junior; Her Daughter, Fay; Two Grandchildren, Twins Michael And Michelle; Her Brother, Darwin; Her Uncle, Elliott; Her Nieces, Nephews, In-laws, Cousins, And Other Relatives, And Many Many Beloved, Loyal And Close Friends.
