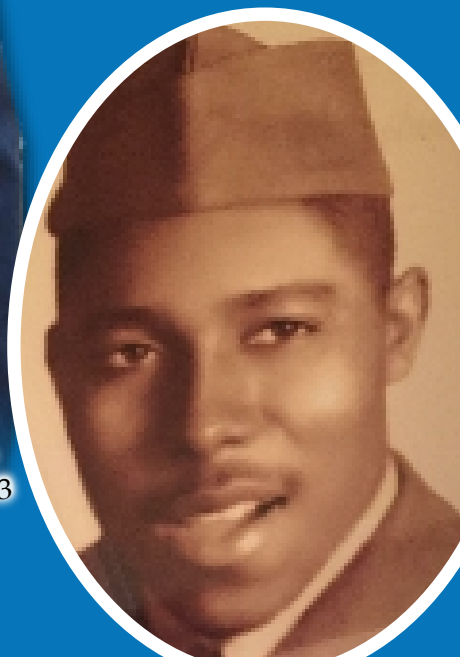

Obituary

Mr. Charles Jackson, better known as “**Buster**” was the son of the late Thomas Jackson and Alberta Chupp Jackson. He was born on February 22, 1931 in Lugoff, South Carolina and departed this earthly life on Sunday, December 10, 2017.

Buster started serving in the US Army in 1953. He received an Honorable discharge in 1961 and was awarded the National Defense Service Medal, the Korean Service Medal, and the United Nations Service Medal. The National Defense Service Medal was awarded to Buster for honorably serving The United States Army during periods of national emergency. The Korean Service Medal is the primary United States military honor, awarded for his participation in the Korean War. The United Nations Service Medal is an international decoration awarded for his participation in joint international military and police operations.

After serving in the military, he migrated to New York and found work in the garment district where he worked for many years.

He leaves to cherish his memory: his two children, Charlie Strong of Atlanta Georgia, and Pamela Norris of Tobyhanna, Pennsylvania; five grandchildren, Shelah J. Strong, Hadiya Strong and Khonsu-Hotep Amun, Dayanna Norris and Destiny Norris; two sisters, Virginia Floyd of Queens, New York and Shirley Beatty (Charles) of Charlotte, North Carolina; a host of nieces, nephews, cousins, and other relatives and friends.

Buster was preceded in death by his four brothers, Thomas Jackson Jr., James Jackson, Nathaniel Jackson, Benjamin Jackson and two sisters, Edna Jennings, and Gertrude Lewins.
