

He retired from J.W. Pierson Oil Company as a Truck Driver after 25 years of service. He was known as the "Oilburner man" for the community who fixed everyone's furnaces and would never leave a job undone. He made sure everyone got heat no matter if it took him all night. Previously, Teddy was employed as a Truck Driver for Holmes Fuel Oil Company for many years. He also worked as a Custodian for Union County College for many years. He was best known for always having his cigar in his mouth.

On Monday, January 15, 2018, Teddy passed away at St. Mary's in Orange, New Jersey at the age of 93.

He was preceded in death by his wife, Lillian Arrington; son, Bernard Dodger; daughter, Dolores Elliott; and ten brothers and sisters.
