<u>Obituary</u>

Charles Linberg Coleman was the son of the late Lillie Coleman. He was born on May 13, 1932 in Marion, South Carolina. Charles received his education through Marion, South Carolina public school system. After graduating in 1951, he moved to New York City. A year later, in January 1952, Charles was drafted into the military. After spending two years in the Army, he obtained employment in the Garment District in Lower Manhattan and later worked at a meatpacking company in New Jersey.

While working in downtown New York City, Charles met Mary E. Perkins. They later married and had three sons, Elliott, Dwayne and Charles, Jr.

In 1982, Charles began working as a Maintenance Technician with The New York City Housing Authority. Charles was a very active and engaged employee. While working for the Housing Authority, he advocated for workers' rights. As a firm advocate, he became a shop steward for the local union. Charles retired from New York City Housing Authority in 1994.

In 1985, Charles became a Mason and eventually progressed to become the Worshipful Master of St. John's Lodge #29. In addition, he was Exalted High Priest of the Rising Sun Chapel No. 4. as well as a member of the Consistory Chapter No. 3. He was a Noble in the Shriners and an Honorary Past Potentate in Medina Temple No. 19. Charles loved being a Mason, socializing with his brothers, traveling to conventions and participating in activities.

Aside from leadership activities as a Mason, Charles' favorite sport was fishing. He enjoyed traveling with his friends to popular fishing locations. Additionally, Charles was a staple in his community often helping anyone in need. He was a strong presence at the local senior center, election office and within the neighborhood in which he lived. He frequently drove seniors to their appointments, shared his knowledge with neighborhood youth and was always there for others when called.
