Junior would spend hours with family at functions and travel home after having his favorite signature "Blue Hawaiian" drink, never giving a second thought to using a narcotic again.

Junior was a living testimony of wanting life. He treasured family time and family values. He created his persona of D.J Bro Luv and dedicated himself to his craft of music outside of the 30 plus years he was a dedicated employee working amongst coworkers who became family at CHEFS CHOICE food distributors also here in Brooklyn. There he was known as J.R and had grown from just a kid trying to get his life back on track to a management status. He was welcomed there with open arms.

Junior leaves behind to mourn: three children, Tameeko Crews, Ronnisha Ross and Lateek Cohen; four siblings, Dora Savage, Jennine Allen, Monique Savage and Jamel Savage; three brothers-in-law, Walter Ross, Jr., Raymond Strother and Neil Allen; three aunts, Eva Hayes, Tina Jones and Lola Jones; a host of favorite nieces and nephews; his eight grandchildren and many, many cousins who dearly loved him.
